The Situation of Children Worldwide

In 2015, PLAYGROUNDS FOR THE WORLD focused on the implementation of our first project in Brazil.

PLAYGROUNDS FOR THE WORLD sees its central commitment to children in educational aid and its practical implementation. It is one of the few organizations that supports the right of children to free play. Whoever wants to prevent a lost generation must give children a future. PFTW wants to strengthen understanding and solidarity with children and you can contribute to it!

Children are experts in certain things

There are more than 2.2 billion children in the world. Almost 2 billion of them live in developing countries. The circumstances that these children face are often precarious. Children therefore need advocates. Children are the future of a country and a region. What this future looks like depends on what we do today to provide them a perspective in the face of war, violence and poverty.

Be it natural catastrophes or manmade disasters, children in the world are becoming victims of crises all over the world. These catastrophes affect children on a previously unknown scale and often lead to trauma. Some of these disasters make headlines, but many stay below the radar. The affected children are particularly vulnerable and therefore need a lot of help.

To counter ongoing crises is at the same time to promote peace. For children, this means that they are given a structured learning environment as quickly as possible. School education gives children physical, psychosocial, and intellectual protection, which can be both life-saving and life-sustaining. Schools give children a sense of normalcy and a necessary structure that can protect them against trauma in times of need, poverty, and disasters. Another cornerstone that reduces trauma is playing. Therefore, education and protection programs need support not only in acute crisis situations, but in a reliable way that stretches beyond.

PLAYGROUNDS FOR THE WORLD therefore supports the development of playgrounds and pedagogical projects to benefit the direct school environment of the affected children.



Educandarío – A Children's Day-Care Center in the Upper Reaches of the Amazon

Reginaldo and Imoto had just bid farewell to the Franciscan nuns and the teachers of the Educandarío, a children's day-care center. As soon as the two playground builders got into in the car and started to drive along the ascent of the school grounds, they saw in the rear-mirror a picture that would have been incomprehensible to an outsider, but which was perfectly familiar to the two of them. They saw, reflected in the car's rear-view mirror, the adult women



and men running laughing toward the newly built swings, rocking merrily and unobserved.

This playground is one of the elements of a pedagogical and didactic project, which has been implemented at the Educandarío in Cruzeiro do Sul, located on the upper reaches of the Amazon in Brazil. A total of 150 children aged between two and five years have so far benefited from this



project. The social situation of the children is precarious as they are fully dependent on the daycare facility and the hot meals provided. Most of the children live in the nearby favela. Some of their parents suffer from leprosy, which is why they are often unable to feed themselves and their families. The facility is open as a day-care center for all children who have either lost their parents or come from conditions of extreme poverty. For the children, Educandarío is the only counterbalance that ensures the normalcy of their everyday life.

The aim of the project was to improve the

teaching and learning environment of the children. Before PFTW's intervention, there were hardly any playing materials for the children at hand, not to mention children's books. In front of the children's playground, there used to be a large garden in which the children could play.

The project involved a training course for 15 teachers and tutors, a set of reading books and didactic material, as well as the construction of a playground to promote the children's motor, social, and cognitive abilities.

What the playground builders Imoto and Reginaldo had seen in their rearview mirror was comprehensible for the two, who came from Rio de Janeiro. In Cruzeiro do Sul, these types of playgrounds were completely unknown, and the adults who had hurried to the swings had never had the opportunity to play with such devices. Their reaction was only too understandable!



The construction of the playground attracted


the attention of the whole city. The children were given play elements such as animal-shaped seats suspended on a flexible spring and a nest swing, which they had never played with before.

A nest swing, in which several children can rock back-and-forth at the same time, is not known in Brazil as a play element at all. However, there is an important reason why the nest swing should necessarily be included in the project: The nest swing not only allows several children to have fun together, it actually makes it possible for disabled children to rock in them. An adult can very well sit in the swing while holding a child in her or his arms.

The development of the playground was also noticed by the local people. Many parents' employers could not help themselves and joined in building the playground. Across from Educandarío is also a primary school. Every day, the schoolchildren looked longingly over the fence at the swings, the slide, the small car with the caravan and the spring animals.

In the evening, craftsmen came out of town, secretly surveying the elements of the game. When Imoto and Reginaldo heard of this, they only laughed and told the nurses: "This is exactly what we want. We want local craftsmen to copy and produce the toys themselves." In the end, Imoto said to Reginaldo: "You know, I have built a lot of playgrounds, but never have I felt such great satisfaction as with these people and these children in Cruzeiro do Sul!"

For PFTW, the satisfaction is that many generations of children will play with these elements. And, who knows, maybe their educators too?
